Applicant agrees to pay for all purchases according to the terms of HPI Emblem which is also listed at www.hpiemblem.com/faq. No other credit terms or condition of purchase orders different from the terms of HPI Emblem will become part of any sales agreement, purchase orders or other documents unless specifically approved in writing by HPI Emblem. Any customer ordering from HPI Emblem represents and warrants to HPI Emblem that you have the unrestricted right and authority to use, copy and distribute each copyright, trademark, service mark, trade name, logo, statement, portrait, graphic, artwork, photograph, picture or illustration of any person or any other intellectual property in the way it is applied to HPI Emblem's custom product. You acknowledge that HPI Emblem is relying upon your representation and agree to indemnify and hold HPI Emblem harmless from any and all costs and damages (including costs of investigation and defense) from any claims contesting the accuracy of your representations.

Conditions for freight shall be F.O.B. Los Angeles unless otherwise noted and approved in writing by HPI Emblem. No items will be accepted for return without prior approval and all orders are subject to a restocking fee subject to the discretion of HPI Emblem and shall be no less than 15%, if assessed. No deduction will be allowed by HPI Emblem unless otherwise approved in writing by HPI Emblem. Payments may be applied against balances at the discretion of HPI Emblem. HPI Emblem may revoke at its discretion the credit availability and for whatever reason as it deems appropriate. HPI Emblem may raise and lower credit limits at its discretion without notice to Applicant.

Applicant agrees to pay any service charges that may accrue on any late unpaid balance, at the highest rate allowed by law or no less than one point seven percent (1.7%) per month (20.40% annually), at the discretion of HPI Emblem. Applicant understands and agrees that upon any returned check, HPI Emblem may impose a "minimum" returned check charge of \$30.00 or the highest amount allowable by law, for which Applicant will be responsible. Additionally, Applicant understands and agrees that Applicant shall be responsible for all actual collection fees and costs, all actual litigation costs and all actual attorney's fees in connection with the collection or litigation of any actual delinquent amount owed by Applicant to HPI Emblem, where allowed by law. In the event of any dispute over any balances owed by Applicant to HPI Emblem, HPI Emblem will refrain from assessing any service charges and any collection activity until it is determined whether or not the amount is legitimately owed. If it is determined the amount is accurate, HPI Emblem reserves the right to assess service charges from the original date at the discretion of HPI Emblem.

Applicant expressly agrees to submit to personal jurisdiction in California and that the forum for any litigation pursuant to this agreement or any other contract between HPI Emblem and Applicant, whether suit is brought by HPI Emblem or Applicant, shall be the County of Los Angeles, State of California.
